- 1) Call to order: Chairperson Friday called the meeting to order at 6:03pm.
- 2) Roll call (as performed during Public Hearing)
- 3) Verification of proper notice (as performed during Public Hearing)
- 4) Approve agenda: Motion to approve (Joy/Bergeson). Motion carried- 5 yes.
- 5) Amend and/or approve proposed 2026 budget: **Motion to approve (Wortner/Coble). Motion carried- 5 yes.**
- 6) Public comment (*limited to 3 minutes per person with no time donations from others, agenda items only*), start by stating name/address & agenda item(s) to be addressed: **None heard.**
- 7) Announcements:
